PRT is maintained by the IPM Institute of North America, Inc., an independent non-profit organization formed in 1998 to leverage market-based power to improve health and environment through Integrated Pest Management, or IPM, and other best practices. Primary funding for the development of PRT is through user and organization fees. PRT is made available to You subject to the following terms and conditions. By using PRT, you signify that you have read and agree to the Master Subscription Agreement.

1. Definitions

- "Affiliate" means any entity that directly or indirectly controls, is controlled by, or is under common control with the subject entity. "Control," for purposes of this definition, means direct or indirect ownership or control of more than 50% of the voting interests of the subject entity.
- "Agreement" means this Master Subscription Agreement.
- "**Content**" means information obtained by Us from Our content licensors or publicly available sources and provided to You.
- "**pesticiderisk.org**," and "**Pesticide Risk Tool**" refer to Our trademark and to the websites that host the Purchased Services.
- **"Malicious Code"** means code, files, scripts, agents or programs intended to do harm, including, for example, viruses, worms, time bombs and Trojan horses.
- "Normal Business Hours" means Monday through Friday, 8AM to 4PM (US Central Time Zone).
- **"Purchased Services"** means the products and services that You purchase through subscription regardless of whether a fee is paid or collected for Your subscription. "Purchased Services" exclude Content.
- **"Third-party Program"** means an entity operating a standards program or certification that requires or provides credit to participants for using the Pesticide Risk Tool.
- "User" means an individual who is authorized by You to use the Purchased Services or Content, for whom You have ordered the Purchased Services, and to whom You (or We at Your request) have supplied a user identification and password. Users may include, for example, Your employees, consultants, contractors and agents, and third parties with which You transact business.
- "We," "Us" or "Our" refers to the IPM Institute of North America, Inc.

2. Acceptance of Terms and Conditions

The following describes the terms on which We offer You access to the Purchased Services and Content. By accessing the Purchased Services or Content, you agree to these terms and conditions. 3. Fees and Subscriptions

1. Terms of the subscription

Unless otherwise specified, Your subscription will be on an annual basis starting on the day of Your payment or use of Your PIN provided by a Third-party Program. The first time You log into pesticiderisk.org after Your subscription has expired, You will be prompted to submit payment or enter Your PIN for the next subscription term unless you have authorized automatic payment for renewal of your subscription for another equal term.

2. Subscription Agreement

Subject to Our receipt of Your payment for the Purchased Services or use of Your PIN provided by a Third-Party Program, and subject to the restrictions set out in this Agreement, and the other terms and conditions of this Agreement, We hereby grant You a non-exclusive, non-transferable right to use the Purchased Services during the subscription term solely for Your internal business operations.

3. Sliding scale fee policy

We are a non-profit entity, aiming to assist in the reduction of negative impacts of pesticide applications. Our goal is to make the Purchased Services accessible to all who might benefit from the Purchased Services by basing the subscription fee on Your organization income.

You must select of the correct subscription fee based on Your business income. We reserve the right to request documentation from You to determine if You have selected the correct subscription fee. If You select an incorrect fee, We reserve the right to suspend Your access to the Purchased Services until the correct fee is paid.

4. Use of Service and Content

1. Your responsibilities

- 1. You are responsible for the accuracy, quality and legality of Your Data and the means by which You acquired Your Data.
- 2. You will use commercially reasonable efforts to prevent unauthorized access to or use of the Purchased Services. You must notify Us promptly of any unauthorized access or use.

- 5. You agree that Our liability for any loss or damage resulting from Your use of the Purchased Services or Content is strictly limited to a pro-rated refund on the unused portion of Your subscription fee for the current subscription period.
- 6. You agree that it is solely Your responsibility to ensure that Your pesticide applications meet all applicable regulations. We provide no information or guidance on pesticide or pesticide use regulations, rules or other legal requirements.

2. Our Responsibilities

- 1. We will, during the subscription term, provide the Purchased Services to You subject to the terms of this agreement.
- 2. We will make commercially reasonable efforts to make the Purchased Services available 24 hours a day, seven days a week, except for planned maintenance carried out at a time scheduled. If planned maintenance is likely to result in the Purchased Services to be unavailable to You for more than 30 minutes, We shall provide 48-hours advance notice of planned maintenance by posting such notice on the pesticiderisk.org website.
- 3. We will make commercially reasonable efforts to perform unscheduled maintenance outside of Normal Business Hours.
- 4. We will make commercially reasonable efforts to ensure the quality and accuracy of the risk estimates included in the Purchased Services., with the goal of minimizing the chance that risk index values are substantially underestimated.
- 5. We will, as part of the Purchased Services and at no additional cost to You, provide You with the Our standard customer support services during Normal Business Hours.

3. Restrictions on website use

- 1. You will not make Purchased Services or Content available to anyone other than You.
- 2. You will not sell, resell, license, sublicense, distribute, rent or lease any Purchased Services or Content, or include any Purchased Services or Content in a Purchased Services bureau or outsourcing offering unless approved by Us.
